SET UP GUIDELINES

The 2024 Morongo Basin Orchid Festival will take place in the front of Gubler Orchids Nursery, 2200 Belfield Blvd., Landers, on Saturday, October 5, 2024 from 10am to 5pm and on Sunday, October 6, 2024 from 10am to 3pm.

The festival grounds will open at 8:00 am for non-profit/Vendor booth set-up only. You may make arrangements to setup the night before with your EZup and tables. Participants must check in, and turn in the Event Booth Agreement, before setting up your space. Once the agreement has been accepted, you will be shown your space location. All non-profit/vendor participants should plan to set up outdoors on the festival grounds and electricity will not be provided. Participants are highly recommended to bring their own shade covers, tables, and chairs as none will be provided for you. You will have a public WiFi access.

All non-profit/vendor participants who have booth space must arrive at the festival grounds before 8:30am to set up, allowing enough time to unload your items and then move your vehicles to the designated parking area on the west south side of the festival grounds,

NO PARKING IN THE FRONT PARKING LOT

Handicap parking will be provided in the vendor parking area.

Cars will not be allowed to remain in the festival activity lot after 9:30 am For safety reasons, cars will not be allowed to reenter the festival activity lot until after the festival closes each day. On Saturday the festival closes at 5:00pm and Sunday at 3:00pm.

You are welcome to leave your setup overnight, just take your valuables and product with you.

Food and beverages will be available for sale throughout the festival.
